1. **Taxes/Duties/Etc.:** All applicable taxes should be clearly and separately mentioned in the commercial bid.

2. **Penalty:** Failure to supply or commission all or some equipments on or before the stipulated date will entail a penalty equal to 0.5% of the total value of the contract price per week.

3. Supply of materials within 10 to 15 days.

4. Earnest Money

- a. Parties are required to deposit the Earnest Money (of Bill) of the specified rates or amount as specified on the tender documents in form of Demand Draft or Bank Guarantee, No other mode of payment is acceptable.
- b. The EMD shall be refundable to un-successful parties after placing Purchase Order.
- c. No interest shall be payable on Earnest Money by NATIONAL ARCHIVES OF INDIA
- 5. **WARRANTY:** Onsite warranty for all Hardware/ Software delivered and installed for minimum for one year. New installation and integration with existing LAN setup includes **but not limited to** the following tentative work:

1. Indoor UTP CAT 6 Cable Laying through PVC Pipe, Casing including all materials

2. Removal of existing UTP CAT 5cable along with PVC

pipe,I/O,BOX,etc

3. Preparation of Actual Bill of Material based on Survey and requirements of NATIONAL ARCHIVES OF INDIA.

4. Installation of 480 No. of IO's (270 for LAN and 150 for NKN

connectivity).

5. Laying of CAT6 UTP Cable and cabling must be properly "structured" and remove the CAT5 cables and other existing network accessories.

6. Labelling of Cables, I/Os, Jack Panel, Switches for new connections

7. Repair/Refurnishing work owing to the cabling or any other work related to this Project. There should not be any hanging or uncovered wire.

8. Patch cord should be of branded and factory crimped.

9. Equipment furnished shall be complete in every respect with all mountings, fittings, fixtures and standard accessories normally provided with such equipment's and/or needed for National Archives of India. Completion and safe operation of the equipment's as required by applicable codes though they may not have been specifically detailed in the tender document.

10. The installation of equipments shall be accepted only after

installation tests are over.

- 11. The vendor has to be provide a Tethering and mobile hotspot facility in research room and library of National Archives to have the limited access of internet to users.
- 12. The vendor has to provide full structure diagram of the complete Network of National Archives of India and also provide the unique ID to individual system on the network so that they can be accessed on the network of NAI.

13. The vendor should start the work in phased flow work to complete the work under the fixed timeline of three months and the work of the office should not suffer due to network disconnection.
