#### MINUTES OF GRANTS COMMITTEE MEETING FOR THE SCHEME OF FINANCIAL ASSISTANCE FOR PRESERVATION OF MANUSCRIPTS/RARE BOOKS TO REGISTERED VOLUNTARY ORGANISATIONS/INDIVIDUALS 2012-2013

Meeting of the Grants Committee for the above scheme was held on 31 July, 2012 in National Archives of India, New Delhi under the Chairmanship of Prof. Mushirul Hasan, Director General of Archives, National Archives of India. The present meeting has been convened in response to the advertisement published on 22 April, 2012.

The members who were present in the meeting is at Annexure-I

Welcoming the Members, the Chairman apprised them of the aims and objectives of the scheme and informed the Committee that the maximum limit of the grant is ₹10.00 lakhs per project per year. The Chairman emphasized the need for a proper monitoring mechanism for better utilization of the grant amount released. He also encouraged support for the proposals received from North-Eastern Region.

2. The Committee unanimously suggested that the National Archives of India give wider publicity of the scheme. National Manuscripts Mission should also be collaborated in this regard.

3. Evaluation of all the projects at the end of every financial year to be carried out.

4. Workshops on Preservation and Conservation of Manuscripts/Rare Books may be conducted to enhance the Archival Heritage of this Country. The Committee also emphasis that two days workshop may be conducted in North Eastern Region especially at Shillong University, Assam, by the Preservation Section of National Archives of India and invite all the grantees of the financial year 2011-12 and 2012-13 and impart the modern Scientific method of preservation & restoration of documents/rare books/manuscripts.

5. The detail Agenda was taken up thereafter. Agenda (Part A) which consisted of 56 complete cases, out of which 27 cases were from States other than North East i.e. Delhi; Gujarat, Jammu & Kashmir, Kerala, Maharashtra, Punjab, Rajasthan, Uttar Pradesh, and West Bengal & 29 cases from North East State Assam.

Subsequently, under the Chairmanship of the Grants Committee all the 56 complete cases in Part A of the Agenda was taken up for consideration and the following decisions was taken by the Grants Committee.

Part A- I-States other than North-East: The Grants Committee considered 20 proposals which were complete in all respect, from the State of Delhi, Gujarat, Jammu & Kashmir, Kerala, Maharashtra, Punjab, Uttar Pradesh and West Bengal.

The Committee also examined/scrutinized the proposals of 18 incomplete cases in Part B which include cases of UC pending/non-receipt of Registration certificate, SLSC or State Archives recommendation/cases where the grantee have already been considered earlier and recommended Grants and cases which under process and hence did not recommend their proposals. Moreover, 27 cases from Part A which were complete in all respect were also not considered i.e. 7 cases from other than North-East States and 20 cases from North East States.
