MINUTES OF GRANTS COMMITTEE MEETING FOR THE SCHEME OF FINANCIAL ASSISTANCE FOR PRESERVATION AND CONSERVATION OF MANUSCRIPTS, RARE BOOKS, OLD AND RARE DOCUMENTS, RECORDS OF HISTORY TO REGISTERED VOLUNTARY ORGANISATIONS/INDIVIDUALS

2015-2016

Meeting of the Grants Committee for the above Scheme was held on 10 August, 2015 in National Archives of India, New Delhi under the Chairpersonship of Smt. Sreya Guha, Director General, National Archives of India. The meeting was convened in response to the advertisement published on 15 May, 2015 in newspapers inviting applications for financial assistance under the Scheme.

- 2. The names of members who were present in the meeting is at Annexure-I
- 3. The Members were welcomed and were apprised about the aims and objectives of the Scheme and the maximum limit of the grant which is ₹10.00 lakhs per project per year.
- 4. The detail Agenda was taken up thereafter. Agenda (Part A) which consisted of 51 complete cases, i.e. 35 cases from the states of Gujarat, Jammu & Kashmir, Karnataka, Madhya Pradesh, Maharashtra, Odisha, Tamil Nadu, Uttar Pradesh, and West Bengal &16 cases from North East State Assam, was discussed.
- 5. The Committee unanimously suggested that the National Archives of India should collaborate with National Mission for Manuscripts (NMM) and check whether the few selected proposals from the Agenda Part –A (Other than North East State) had benefitted from NMM. In this regard, it was decided to send a list of 18 organizations to NMM to verify whether they had done any kind of preservation, conservation, microfilming etc. The same was sent to NMM and they had responded by stating that they have not done any work for these 18 organizations.

The following decisions were taken by the Grants Committee for releasing the Grant.

Part A- <u>I-States other than North-East</u>:- The Grants Committee considered 23 proposals which were complete in all respect, from the State of Gujarat, Jammu & Kashmir, Karnataka, Madhya Pradesh, Maharashtra, Odisha, Tamil Nadu, Uttar Pradesh and West Bengal.

Approved Projects Cost =₹37,50,000/(23 cases from State Other than North East)

75% Central Share =₹28,12,500/-25% Matching Share =₹09,37,500/-

<u>Part A-II- North-East State</u>:-Grants Committee considered and recommended 3 cases for the projects of Registered Voluntary Organizations/Individuals from the State of Assam.

Approved Projects Cost =₹04,00,000/-

(3 cases from North East State)
75% Central Share =₹03,00,000/-

75% Central Share =₹03,00,000/-25% Matching Share =₹01,00,000/-

Grants Committee recommended a total grant =₹41,50,000/-

(Total of Approved project cost including grantees matching share @ 25% i.e. ₹09,37,500/- of Part-A -I ₹37,50,000/- + ₹1,00,000/- of part A-II i.e. ₹4,00,000/-)

75% Central Govt. Share of the above amount of ₹41,50,000/- is ₹31,12,500/-

6. The Grants Committee did not recommend financial assistance to the following:

The Committee also examined/scrutinized the proposals of 14 incomplete cases in Part B which include cases of UC pending/non-receipt of Registration certificate, SLSC or State Archives recommendation and where the grantees have already been considered earlier and recommended Grants and hence did not recommend their proposals.

Moreover, 41 cases from Part A which were complete in all respect were also not considered i.e. 28 cases from other than North-East States and 13 cases from North East States.

Grant Committee recommended total grant of ₹41,50,000/-(Part-A-I ₹37,50, 000/- + Part-A-II ₹4,00,000/-) 75% Central Govt. share ₹31,12,500/- (Part -A-I ₹28,12,500/- + Part-A-II ₹3,00,000/-) and thus the 1st installment i.e. 50% of the Central Govt. share ₹15,56,250/-would be released to the grantee who have submitted the complete Bond and Other requisite papers. The 2nd installment would be released as re-imbursement once the utilization certificate of the entire grant is submitted by the Grantee.
