MINUTES OF GRANTS SUB-COMMITTEE MEETING FOR THE SCHEME OF FINANCIAL ASSISTANCE FOR PRESERVATION OF MANUSCRIPTS/RARE BOOKS TO REGISTERED VOLUNTARY ORGANISATIONS/INDIVIDUALS 2016-2017

The Meeting of the Grants Sub-Committee for the above Scheme was held on 15 November, 2016 in National Archives of India, New Delhi under the Chairpersonship of Sh. Pankaj Rag, Director General of Archives, National Archives of India. The meeting was convened as a follow up action of the Grants Committee meeting held on 16 August, 2016 to discuss the proposals of Odisha & Assam on the basis of their inspections reports and 9 other cases which were directed to furnish complete details the record holdings or revised the proposals.

The names of members who were present in the meeting is at Annexure-I

The Member Secretary welcomed the Chairperson and Committee Members; following it the Committee was apprised about the aims and objectives of the Scheme, citing that the maximum limit of the grant is ₹10.00 lakhs per project per year.

2. The detailed Agenda was taken up thereafter. The Agenda (Part A) which consisted of 26 complete cases, out of which 19 cases were from States other than North East i.e. from the states of Karnataka, Maharashtra, Odisha, Punjab, Tamil Nadu, and West Bengal; whereas 7 cases were from North East State Assam.

Subsequently, the members of the Grants Sub-Committee discussed all the 26 complete cases included in Part A of the Agenda and the following decisions were taken by the Grants Sub-Committee for releasing the Grant in 2016-17 FY.

Part A- I-States other than North-East:- The Grants Sub-Committee considered 19 proposals which were complete in all respect, from the States of Karnataka, Maharashtra, Odisha, Punjab, Tamil Nadu, and West Bengal. The Sub-Committee approved 6 proposals for the grant during current financial year i.e. 2016-17.

II- North-East State:-Grants Sub-Committee considered and recommended the Sub-Committee approved 4 proposals for the grant during current financial year i.e. 2016-17.

The other remaining 16 complete cases (13 cases from other than North-East States and 3 cases from North East States) from Part A were also discussed in the meeting, out of which 15 were not considered for sanction of grant while one case from Madras Literary Society for enhancing the grant amount recommended in earlier grants committee meeting dated 16 August, 2016 was rejected by the Grants Sub-Committee and the amount was retained as sanctioned in previous Grant Committee meeting. The 7 cases from Odisha whose Record Holdings, on the basis of spot inspection report, could not match the figures given in their initial proposal were not recommended for grant whereas the 4 cases of Punjab State were not approved for any amount as their record holdings, being of general collection category of 19th century, could not meet the criteria of unique or historically important category. The proposal of Sh. Rohidas Mandir Trust was also not approved by Grants Sub-Committee.

The 3 cases of NE state of Assam were considered but not found suitable for grant recommendation as the record holdings of 2 cases, on the basis of spot inspection report, were not matching the figures submitted by them earlier whereas the inspection of 1 Institute could not be completed.

4. The Sub-Committee also examined/scrutinized the proposals of 21 incomplete cases (16 from Other than NE States and 5 from NE State) in Part B which included the cases of institutions which either avoided the inspection or failed to produce the earlier claimed record holdings or which did not furnish the records holdings' details or which were not covered under the provisions of the Scheme; and did not recommend their proposals for any grant.

The meeting concluded with a Vote of Thanks to the Chair.
