- 2 The departmental Assistant Library and Information officer in Pay Band -2, Rs.9300-34800 plus Grade Pay of Rs. 4600/- with seven years regular service in the grade and possessing a Bachelor's degree in Library science from a recognized University or Institute, shall also be considered alongwith outsiders. In case he or she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 1: The Departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another excadre post held immediately preceding this appointment in the same or some other Organisation or Department of Central Government shall ordinary not exceed four years. The maximum age limit for appointment by deputation (including short term contract)shall not be exceeding 56 years as on the closing date of receipt of applications).

Note 2: For purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006, the date from which the revised pay structure based on the 6th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended bases on the recommendations of the Pay Commission except where there has been merger of more that one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any upgradation.


