Besides, the Chairperson, Grants Committee, may invite expert (s)/professional(s) to attend meeting(s) of the Grants Committee, and/or to tender advice to the Grants Committee.

In case of unavoidable/unforeseen circumstances, an official member may depute his representative to attend meetings of the Grants Committee under prior intimation to the Member-Secretary of the Grants Committee.

II. TENURE:

The Grants Committee is re-constituted for two financial years i.e. 2019-20 and 2020-21. The term of the Grants Committee will expire on 31 March, 2021. The Members will also be eligible for re-appointment.

III. SECRETARIAT

The Secretariat of the Committee will be at the National Archives of India, Janpath, New Delhi-110 001.

IV. MEETINGS:

The Committee shall ordinarily meet at least once in a financial year depending upon the number of applications received and availability of funds.

V. TERMS OF REFERENCE:

The scope of the Committee's activities shall be the following:

To act as a forum to scrutinize all applications/ proposals received under the scheme from Archival Repositories, Libraries and Museums of State/UT Administrations who will submit their application/proposal recommended/approved by the State Level Screening Committee (SLSC) to the Chairperson, Grants Committee, National Archives of India, Janpath, New Delhi-110 001. Where there is no SLSC, the application should be recommended/approved by the Secretary of the Controlling/Administrative department of the respective State Government/UT Administration The Committee will recommend specific amount of grant to be released for the execution of the proposal.

VI. ALLOWANCES:

Members of the Committee will be entitled to draw TA/DA for attending the meetings of the Committee as admissible under the rules. All the special invitees will be entitled to TA/DA etc. at par with the members of the Grants Committee.
