ORDER

- 1. Whereas, as per the judgment No. CC No. RC no. 3(S)/2004/SCR-II/CBI/DLI, dated 26.09.2016, delivered by Ms. Shivali Sharma, Additional Chief Metropolitan Magistrate, (ACMM), Karkardooma Court, Delhi, Shri Shiv Prasad Mahto, Special Grade Record Attendant had been convicted U/s 420/471 IPC dated for submitting forged Scheduled Tribe (ST) Caste Certificate while applying for the Govt. Job. (Orders executed).
- 2. Whereas, DOPTs O.M. No. 36011/1/2012-Estt.(Res.), dated 10.01.2013 stipulates that:

Wherever it is found that a Government servant, who was not qualified or eligible in terms of the recruitment rules etc. for initial recruitment in service or had furnished false information or produced a false certificate in order to secure appointment, he should not be retained in service. If, he is probationer or temporary Government servant, he should be discharged or his services should be terminated. If he has become a permanent Government servant, an inquiry as prescribed in Rule 14 of CCS (CCA) Rules, 1965 may be held and if the charges are proved, the Government servant should be removed or dismissed from service. In no circumstances should any other penalty be imposed."

3. Whereas, rule 41(1) of CCS (Pension) Rules, 1972 provides that:

A Government servant who is dismissed or removed from service shall forfeit his pension and gratuity.

4. Accordingly, in view of above, I, in exercise the power of the Disciplinary Authority under CCS (CCA) Rules, 1965, hereby dismiss Shri Shiv Prasad Mahto, Special Grade Record Attendant, National Archives of India from the government service with immediate effect.
